

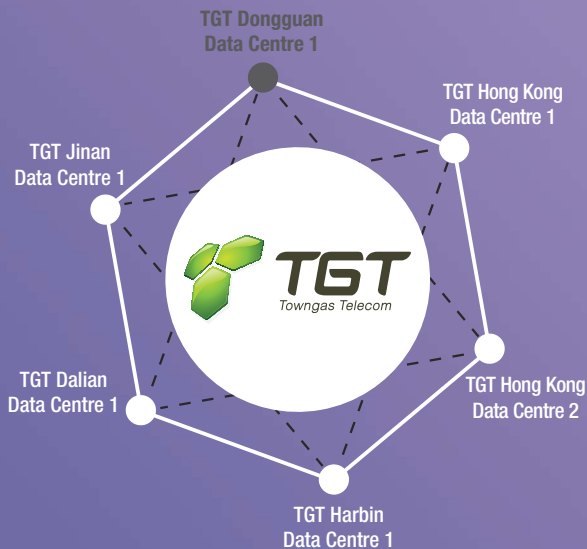


About Us

- Power supply capacity of each substations is 12,000 KVA
- UPS system with 2N redundancy, capable of up to 30 minutes operation for each system at full load
- Diesel Power Generator System with N+1 redundancy
- Underground fuel storage that can power generators for up to 8 hours
- Located only 1km from the oil depot, bound by a fuel supply agreement

Cooling System

- Data hall temperature is maintained at $23\pm 1^{\circ}\text{C}$ and humidity at 40-55%
- Underfloor air supply and top air return
- CRAC with N+1 redundancy, 2N power supply
- Low-temperature water chiller system with ringed network of pipes and physical separation of both paths
- Oil free water chillers for energy conservation and environmental protection
- 6 cold water storage tanks used to avoid data hall temperature exceeding 6°C within 15 minutes during interruption
- Equipped with an 880m³ reservoirs to ensure over 48 hours of contingent water supply

Carrier-Neutral Data Centre

- Access allowance from multiple major telecommunication carriers, including China Mobile, China Telecom and China Unicom, as requested by customers
- Data centre backbone with 2N redundancy
